**Ask of the Board** Adoption by the Board of Education of the Local Plan for the Oakland Special Education Local Plan Area (SELPA) for the 2026-2027 School Years.

**Background** The California Department of Education requires that each Special Education Local Plan Area (SELPA) create, adopt, and implement a Local Plan, Annual Budget Plan, and Annual Service plan. The Governance and Administration section is updated every three years and was adopted last year. The Annual Budget Plan and the Annual Service Plan must be submitted yearly. The Annual Budget Plan indicates the sources and amounts of funding that the SELPA has available to run our programs, and it details the expenditures for Special Education by category. The Annual Service Plan describes each of the Special Education and related services available within the SELPA and indicates where and how they are provided to eligible students.

**Discussion** We ask that the Board vote to adopt the proposed SELPA Local Plan so it can be implemented in the 2026-2027 school year. The plan will guide the services that students with Individual Education Programs receive within all OUSD schools and the charter schools within our SELPA network.

**Fiscal Impact** No Fiscal Impact. Will use existing Special Education funds. Funds can be withheld by the California Department of Education (CDE) if the plan is not adopted in a timely manner.
