# Strengths and Challenges

### **Strengths**

- Strong A-G graduation rates: nearly all graduates at AIPHS met A-G standards in all years of the charter term.
- Economically disadvantaged students have outperformed their OUSD on state test proficiency by at least 20 percentage points in all three years of the charter term.
- College-going rates both schoolwide and for socioeconomically disadvantaged students were higher than the OUSD average for three most recent years, including 12-17 percentage points higher in the most recent two years.

### **Challenges**

- Serves a particularly low percentage (3%) of students with disabilities.
- The school's leadership appears to have minimal involvement in classroom observations or staff coaching.
- Charter Management Organization has not always displayed a willingness to collaborate/partner
  with OUSD: they do not participate in CORE, they did not consent to sharing data with OUSD as
  part of the data sharing partnership with Oakland Enrolls and UC Berkeley, they held facilities
  offers in the Prop 39 process that ultimately they had no intention of accepting.











# Renewal Tier Analysis

- AB 1505 introduced a new 3-tiered system for charter renewal
- State identified the renewal tier (Low, Middle, or High) for each school based on its
   State Dashboard indicators
- AIPHS met Middle Tier criteria

### **Renewal Decision Requirements - Middle Tier Schools**

- Eligible for 5-year renewal term
- May only be denied for academic reasons if the Board makes <u>all</u> of the following written findings:
  - The school has failed to make sufficient progress toward meeting standards for students;
  - Closure is in the best interest of students; AND
  - The decision provided greater weight to academic performance














#### **4 Year Cohort Graduation Rate**














## **English Learner Students 4 Year Cohort Graduation Rate**














#### **4 Year Cohort Graduation Rate**




